ROLL-OFF CONTAINERS POLICIES & PROCEDURES:

THE FOLLOWING ITEMS WILL NOT BE ACCEPTED AT THE FAIRMEAD LANDFILL,

therefore do not place them in the Roll-Off container.

- Liquids of any kind
- Any substance listed as hazardous waste (including needles/sharps)
- Materials that bubble when coming in contact with water
- Materials that make skin itch or irritated
- Oils or petroleum based products
- Acids or materials that dissolve metals, woods, paper or clothing
- Flammable materials
- Dyes, PAINT, thinners, solvents or cleaning fluids
- TIRES & Rims
- Pesticides or related chemicals*Computer monitors or Televisions
- RAILROAD TIES
- Treated Wood
- Telephone Poles
- Cars/Trucks
- Propane Tanks

THIS R/O BIN IS NOT FOR ASPHALT, CONCRETE, DIRT OR ROCKS.

(there is Roll Off boxes for asphalt, dirt, concrete or rock)

YOU WILL BE CHARGED A TRIP FEE & REFUSAL FEE IF PLACED IN R/O BIN.

HAZARDOUS WASTE MATERIAL POLICY:

If any hazardous waste is found in your Roll-Off container, the landfill operator will contact you to remove the hazardous waste from the landfill site within 48 hours.

If you fail to remove the hazardous waste within 48 hours, the Madera County Sheriffs Office will be contacted to report the incident as an illegal dumping of hazardous waste.

1. Asphalt, Concrete, Dirt, or Rocks etc. are not to be loaded more than the marker line on the R/O Bin. (In special R/O Bins)
2. **R/O Bins that are overloaded (10 tons +) will be charged an overload charge equal to an additional R/O Bin rental. Driver may refuse to haul over loaded R/O Bins until the customer adjusts the load.
3. Do not move R/O Bin from placement or block R/O bin for servicing.
4. Have R/O Bin ready on pick-up day. R/O Bin will be tarped by DRIVER, so don't load R/O Bin past top edge of box, must be level with rim of R/O Bin.
5. **Extra charges:** Mattresses, Couches, Large Chairs and Large Bulky items will be charged an additional \$26.02 and up - per item as a hard to handle charge assessed by operator.
6. **Extra fees:**
 - (1) If you wish to keep the R/O Bin longer you must make these arrangements in advance. If no prior arrangements are made, R/O Bin will be automatically pulled on the 8th day. Please call at least 48 hours in advance to arrange a longer rental period. A rental charge of \$10.26 per day will be added for each day beginning on the 8th day of placement.
 - (2) If inaccessible there will be an additional Trip fee \$177.21 + will be charged.
 - (3) R/O Bins placed for 30 days with no activity will be charged a Demurge Fee- \$330.16 each month.
 - (4) Re-Location Fee \$154.07
 - (5) Cancellation Fee of \$17.80 will be added if you decide to cancel after account is setup.
 - (6) Wash Out Fee - \$325.08. **All rates posted on this contract are subject to change without notice.**
7. Barring normal wear and tear, customer is responsible for any damage to bin while in their possession, at \$104.40 per hour plus materials. **In addition, customer is responsible for extra weight fees that might be incurred due to rain, snow etc.**

EMADCO Disposal Service, Inc. or any of its subcontractors (COMPANY), are not responsible for any damages to driveway, lawn or other property. Bin placement is by customers request. Customer is responsible for all risks and damages resulting from bin placement. Non-compliance with the above, may result in additional service charges. Customer expressly agrees to defend, indemnify and hold harmless the COMPANY from and against any and all claims for loss or damage to property or injury to or death of person or persons resulting from or arising in any manner out of customers use, operation or possession of the equipment furnished under this agreement or resulting from COMPANY'S collection from customer of material prohibited and excluded by this service agreement as outlined above. By signing below, I acknowledge that I have read the Roll Off Containers Policies and Procedures and agree to the conditions set down therein.
